WITH THIS PROJECT WE WANT TO ENCOURAGE PEOPLE - ESPECIALLY YOUTH WORKERS - TO IMPROVE THEIR COMPETENCE IN CREATING, SELECTING AND ADAPTING NON-FORMAL EDUCATION METHODS TO IMPROVE THEIR WORK WITH DISADVANTAGED YOUNG PEOPLE.



BY USING NFE WE WANT TO SHOW HOW ENGAGING LEARNING CAN BE, HOW QUICKLY YOU CAN MOTIVATE YOUTH BY USING NFE METHODS, AND ESPECIALLY HOW MUCH EMPOWERMENT CAN NFE BRING TO DISADVANTAGED GROUPS OF YOUNG PEOPLE.



The objectives of the training are:

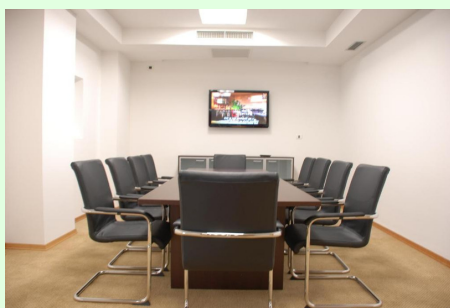
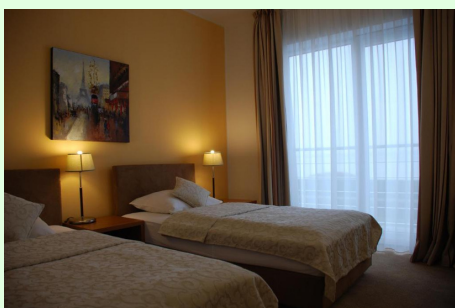
1. The participants will increase their knowledge about the differences and the similarities between non-formal, formal and informal education methods and will understand how and when to use them.
2. By working with various NFE methods, throughout the project, the participants will develop their skills in implementing a NFE method (setting objectives, explaining the rules, supervise the implementation, debriefing) and adapting it to disadvantaged groups of young people.



The implementation of what you have learned during this training course will continue after the project activity. You will have a mentor available for 2 months after the projects ends to help you with the implementation.

A C C O M O D A T I O N

In the venue where we will stay, there is a rule of inside shoes. This means that every participant should bring some shoes that you are going to use only inside the hotel.

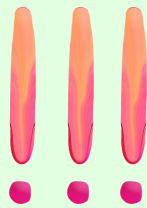
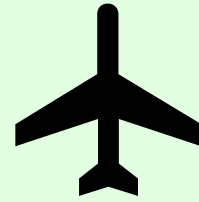

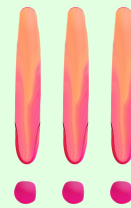




TRAVELING

COVID-19 info

EU countries - You should take the Rapid antigen test or PCR in ENGLISH in your country or have a Digital COVID PASS.

Also you should check what are the specific regulations for your country to travel to Croatia because they might change as the dates come closer.

Non EU countries - You can enter Croatia with a confirmation that the purpose is learning-studying or for tourist reasons. We will provide all necessary confirmations about the program and accommodation to each participant personally.

We will make also an invitation letter for every person in the group in case you will need it on the boarder.

The COVID test if needed to enter the country will be refunded to every participant.

We will inform you about the changes as the arrival day comes closer.

WHAT TO BRING?



HEALTH INSURANCE - don't forget to bring your European Health Insurance Card if you are from an EU country, or other types of insurance if you're not from the EU.



ALL TICKETS, BOARDING PASSES – don't throw any of them, you will need to send them to us after the training. If you lose any of the tickets or boarding passes, we won't be able to reimburse you for those tickets.
